Sub: Supply of B-Twill jute bags to Govt. of Uttar Pradesh against PCSOs issued from 12-03-2019 to 10-05-2019 scheduled to be despatched by Rail.

Sir.

Reference is invited to the letter of even number dated 06-05-2019 and the meeting held in the office of Jute Commissioner on 09-05-2019 & 10-05-2019, as well as officers of U.P. Government on 13-05-2019. Considering the urgency of the situation, certain commitments have been given by the individual jute mills regarding supply. Hence in supersession of this office letters dated 18-03-2019, 18-04-2019, 24-04-2019 and 02-05-2019 and as per advice dated 13-05-2019 of the Govt. of Uttar Pradesh, all loaders have been directed to dispatch the quantity of jute bags against PCSOs issued from 12-03-2019 to 10-05-2019 to the destinations/railheads with scheduled quantity strictly, as per priority, as indicated below:-

Jute mills are accordingly directed to dispatch their allocated quantity to any of these twenty destinations/railheads as mentioned above, irrespective of the destinations stated in their PCSOs. They should ensure strict adherence to their commitments given. No further manual amendments shall be needed as long as the inspected stocks are sent to any of the twenty (20) destinations/railheads tabulated above. - (ii) Payment section It is advised that they shall process the bills to be submitted by jute mills despite difference of destinations in PCSOs / Inspection Notes, RRs, etc.
- (iii) All loaders- They are directed to ensure movement of rakes as stated in the above table.
- (iv) IJMA- For information and necessary action. It is requested to monitor the situation on a daily basis and also co-ordinate with the Railway authorities so that rakes are available on a regular basis for immediate dispatch of the inspected goods. A report may be sent to this office daily.
